

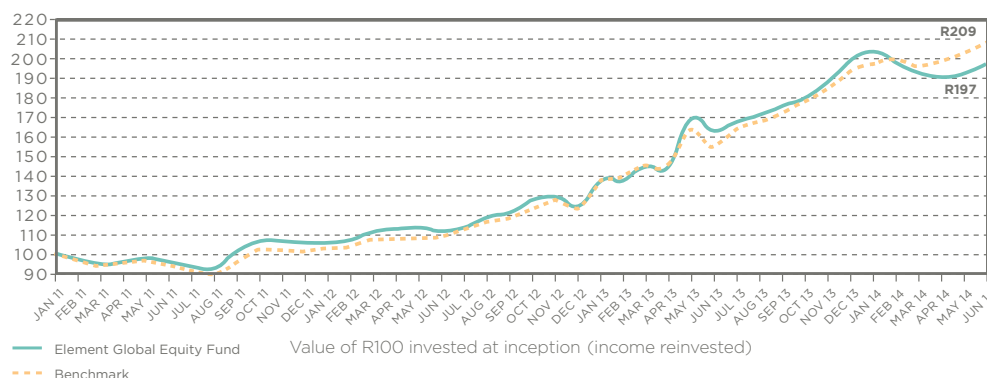
FUND OBJECTIVE

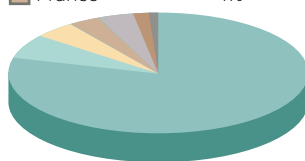

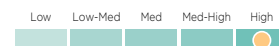
STATUTORY INFORMATION
