FUND OBJECTIVE

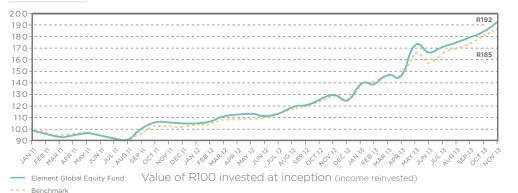

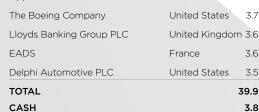
