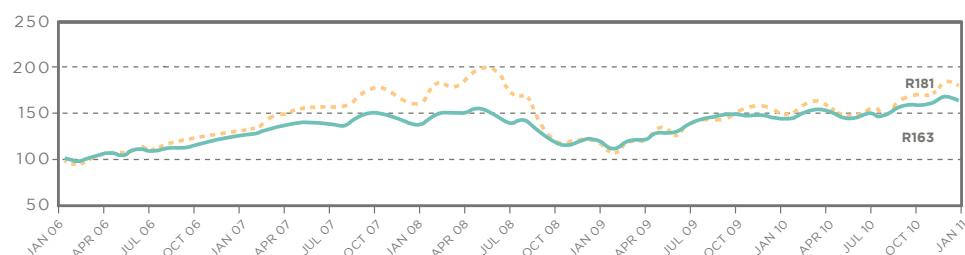
FUND OBJECTIVE:

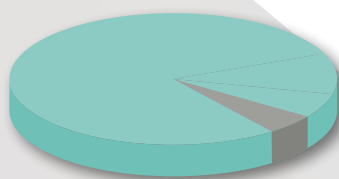

STATUTORY INFORMATION

Figures quoted are from Element Investment Managers (Pty) Limited, for the period ended January 2011, for a lump sum investment, using NAV-NAV with income distributions reinvested.
