

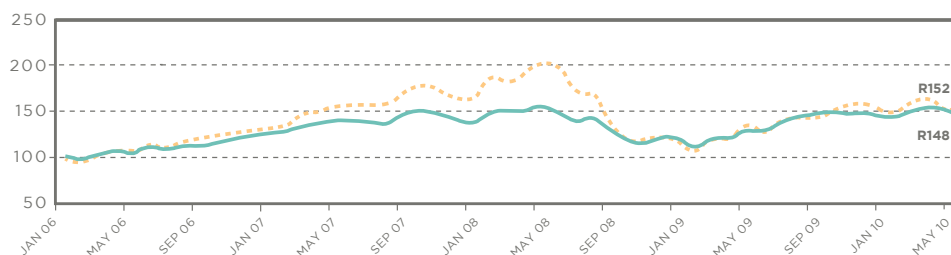
FUND OBJECTIVE:

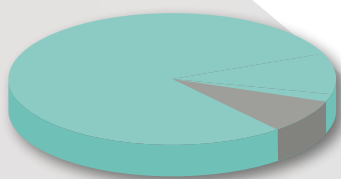

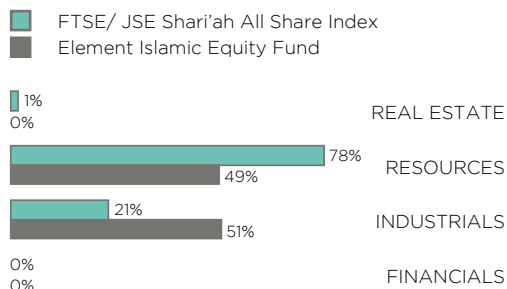

STATUTORY INFORMATION

Figures quoted are from Element Investment Managers (Pty) Limited, for the period ended May 2010, for a lump sum investment, using Class A NAV-NAV prices with income distributions reinvested.
