The Fraters Flexible Fund aims to achieve a steady growth of capital and income for investors. The fund is actively managed and has been designed to operate as flexibly as possible within the constraints of the South African market. The Fraters Flexible Fund is Fraters' "best view" on domestic asset allocation, combined with individual instrument selection based on bottom-up research conducted by our in-house research team. Fraters signed the United Nations Principles for Responsible Investment (PRI) in May 2006. In signing the PRI, we have committed to adopt and implement them where consistent with our fiduciary responsibilities. We believe that this improves our ability to meet commitments to investors as well as better align our investment activities with the broader interests of society. Fraters was the first South African investment manager to sign the PRI.

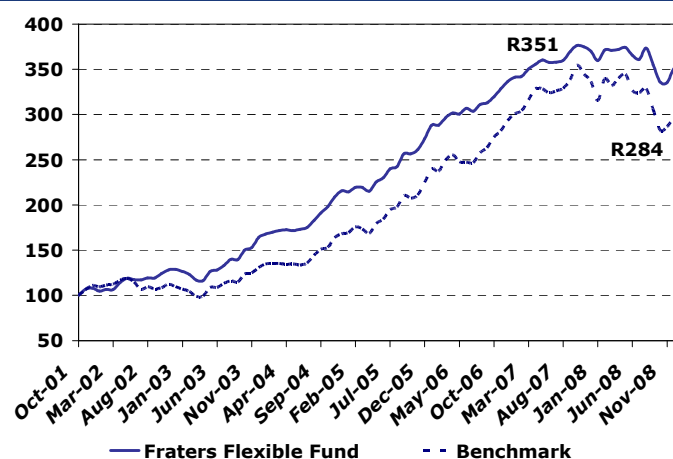

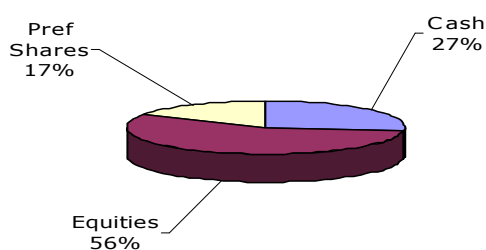

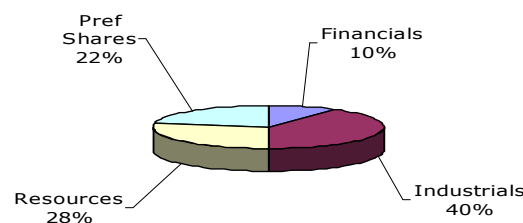
TRACK RECORD
