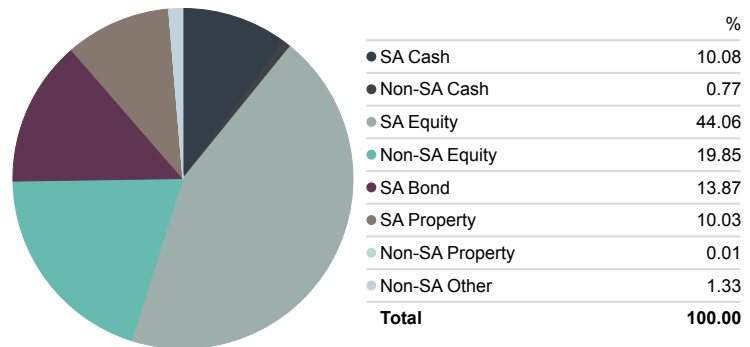

Risk Profile

Aggressive

You can afford to take on a higher level of risk (i.e., have a greater exposure to equities) because of your investment time horizon and/or your appetite for risk. You know that in taking the risk, you need to be patient if you want to achieve the results. So you are willing to invest for the long-term and are prepared to tolerate some volatility in the short term, in anticipation of the higher returns you expect to receive in five years or beyond.

Glossary Terms

Annualised Returns

Annualised return is the weighted average compound growth rate over the period measured.

Asset Allocation

Asset allocation is the percentage holding in different asset classes (i.e. equities, bonds, property, etc.). It is used to determine the level of diversification in a portfolio.

Cumulative Returns

Cumulative return is the total growth experienced over the period measured.

Distributions

The income that is generated from an investment and given to investors through monthly, quarterly, bi-annual or annual distribution pay-outs.

Diversification

This is a strategy designed to reduce risk within a portfolio by combining a variety of investments (or asset classes) such as equities, bonds, cash or property, which are unlikely to all move in the same direction at the same time. This is designed to reduce the risk (and protect against capital losses) within a portfolio. Diversification allows for more consistent performance under a wide range of economic conditions as it smoothes out the impact of negative market events. The positive performance of some investments or asset classes should neutralize the negative performance of others.

Financial Instruments

Derivatives also known as financial instruments (such as a future, option, or warrants) whose value derives from and is dependent on the change in value of an underlying asset (such as a commodity, currency, or security) to protect against risk (capital losses).

Fund Objective

The fund objective is the portfolio's core goal.

Fund Strategy

The fund strategy is the way that the fund is managed to achieve the fund objective.

Information Ratio

The Information Ratio measures the market risk-adjusted performance of an investment or portfolio. The greater a portfolio's Information Ratio, the better its risk-adjusted performance has been compared to the market in general.

Collective Investment Schemes

Collective Investment Schemes (CIS) (also called unit trusts) are portfolios of assets such as equities, bonds, cash and listed property, in which investors can buy units. They allow private investors to pool their money together into a single fund, thus spreading their risk across a range of investments, getting the benefit of professional fund management, and reducing their costs.

Market Capitalization

Market capitalization is the total value of the issued shares of a publicly traded company; it is calculated by multiplying the share price by the number of shares in issue.

Maximum Drawdown

The maximum drawdown measures the highest peak to trough loss experienced by the fund.

Participatory Interests

When you buy a unit trust, your money is pooled with that of many other investors. The total value of the pool of invested money in a unit trust fund is split into equal portions called participatory interests or units. When you invest your money in a unit trust, you buy a portion of the participatory interests in the total unit trust portfolio. Participatory interests are therefore the number of units that you have in a particular unit trust portfolio.

Sharpe Ratio

The Sharpe Ratio measures total risk-adjusted performance of an investment or portfolio. It measures the amount of risk associated with the returns generated by the portfolio and indicates whether a portfolio's returns are due to excessive risk or not. The greater a portfolio's Sharpe ratio, the better its risk-adjusted performance has been (i.e. a higher return with a contained risk profile, where the portfolio manager is not taking excessive risk to achieve those returns).

Standard Deviation

Standard deviation (also called monthly volatility) is a measure of how much returns on an investment change from month to month. It is typically used by investors to gauge the volatility expected of an investment.

Quarterly Commentary

The Element Flexible SCI Fund realised a total return of -2.3% for the quarter to the end December 2018, underperforming its benchmark (CPI+ 5%) return of 2.4% over this period. The December 2018 quarterly performance brings the rolling one year total performance of the Fund to 0.5% (net of fees) – underperforming its benchmark return of 9.5% over the same period. It should however be noted that on a relative basis the Fund is rated in the top quartile of its category over the past rolling three years.

The quarter saw pretty dismal performance coming from the majority of the local asset classes, with the JSE All Share Index (ALSI) down -2.2%, the JSE Property Index (SAPY) down -1.0%, and the JSE All Bond Index (ALBI) down -1.1%. Exposure to offshore assets provide some relief, as the USDZAR weakened by 3%, coupled with the S&P500 (as an indicator for developed equity markets) strengthening by 7.2% over the period.

The quarter saw another pretty dismal performance coming from the equity and property sector, with global equities (as measured by the MSCI World Index in ZAR) down -12.7% local equities (as measured by the JSE All Share Index) down -4.9%, and the local property sector (as measured by the JSE Property Index) down a further -4.0%. Our exposure to preference shares provided some reprieve, with the sector up 4.1% for the quarter. Local bonds strengthened along with the stronger Rand, and the All Bond Index ended the quarter up 2.8%.

It is notable that on a relative basis, our domestic equity holdings outperformed its benchmark (ALSI) over the quarter - this was largely to our overweight position in AngloGold. AngloGold outperformed materially over the quarter as investors moved to safe haven assets as broader equity markets declined over the quarter.

The Fund's performance was negatively impacted by our offshore exposure, even though our global equity holdings outperformed its benchmark (MSCI World Index in ZAR) on a relative basis. Global Equities came under severe pressure during the quarter as the tech heavyweight stocks such as Apple, Amazon and Nvidia underperformed - these stocks were the leaders of the bull-run in global equity markets previously. On the positive side, our exposure to Petrobras, a Brazilian petroleum company, contributed positively to the Fund's performance over the quarter.
