The objective of the portfolio will be to achieve long term capital appreciation without concentrating on income requirements and to create an internationally diversified equity portfolio for investors.

Fund Strategy

The investment policy followed by the manager will focus on achieving this by investing in international equity securities, listed property, money market instruments, and assets in liquid form. The portfolio will be predominantly invested in international securities in developed countries. The portfolio may also invest in equity derivatives, index tracking funds and preference shares.

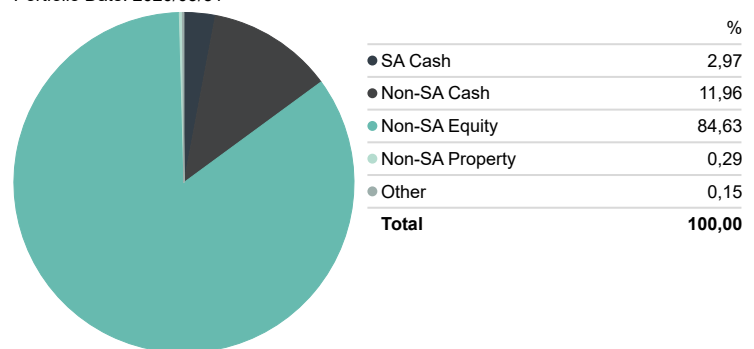

Risk Profile

Aggressive

You can afford to take on a higher level of risk (i.e., have a greater exposure to equities) because of your investment time horizon and/or your appetite for risk. You know that in taking the risk, you need to be patient if you want to achieve the results. So you are willing to invest for the long-term and are prepared to tolerate some volatility in the short term, in anticipation of the higher returns you expect to receive in five years or beyond.

Glossary Terms

Annualised Returns

Annualised return is the weighted average compound growth rate over the period measured.

Asset Allocation

Asset allocation is the percentage holding in different asset classes (i.e. equities, bonds, property, etc.). It is used to determine the level of diversification in a portfolio.

Cumulative Returns

Cumulative return is the total growth experienced over the period measured.

Distributions

The income that is generated from an investment and given to investors through monthly, quarterly, bi-annual or annual distribution pay-outs.

Diversification

This is a strategy designed to reduce risk within a portfolio by combining a variety of investments (or asset classes) such as equities, bonds, cash or property, which are unlikely to all move in the same direction at the same time. This is designed to reduce the risk (and protect against capital losses) within a portfolio. Diversification allows for more consistent performance under a wide range of economic conditions as it smoothes out the impact of negative market events. The positive performance of some investments or asset classes should neutralize the negative performance of others.

Financial Instruments

Derivatives also known as financial instruments (such as a future, option, or warrants) whose value derives from and is dependent on the change in value of an underlying asset (such as a commodity, currency, or security) to protect against risk (capital losses).

Fund Objective

The fund objective is the portfolio's core goal.

Fund Strategy

The fund strategy is the way that the fund is managed to achieve the fund objective.

Information Ratio

The Information Ratio measures the market risk-adjusted performance of an investment or portfolio. The greater a portfolio's Information Ratio, the better its risk-adjusted performance has been compared to the market in general.

Collective Investment Schemes

Collective Investment Schemes (CIS) (also called unit trusts) are portfolios of assets such as equities, bonds, cash and listed property, in which investors can buy units. They allow private investors to pool their money together into a single fund, thus spreading their risk across a range of investments, getting the benefit of professional fund management, and reducing their costs.

Market Capitalization

Market capitalization is the total value of the issued shares of a publicly traded company; it is calculated by multiplying the share price by the number of shares in issue.

Maximum Drawdown

The maximum drawdown measures the highest peak to trough loss experienced by the fund.

Participatory Interests

When you buy a unit trust, your money is pooled with that of many other investors. The total value of the pool of invested money in a unit trust fund is split into equal portions called participatory interests or units. When you invest your money in a unit trust, you buy a portion of the participatory interests in the total unit trust portfolio. Participatory interests are therefore the number of units that you have in a particular unit trust portfolio.

Sharpe Ratio

The Sharpe Ratio measures total risk-adjusted performance of an investment or portfolio. It measures the amount of risk associated with the returns generated by the portfolio and indicates whether a portfolio's returns are due to excessive risk or not. The greater a portfolio's Sharpe ratio, the better its risk-adjusted performance has been (i.e. a higher return with a contained risk profile, where the portfolio manager is not taking excessive risk to achieve those returns).

Standard Deviation

Standard deviation (also called monthly volatility) is a measure of how much returns on an investment change from month to month. It is typically used by investors to gauge the volatility expected of an investment.

Quarterly Commentary

The Element Global Equity SCI Fund ("Fund") realised a total return in ZAR of -3.3% for the quarter to the end of March 2020, underperforming the benchmark (MSCI All World Index Total Return in ZAR) performance of +0.8% over the same period.

The March 2020 quarterly performance brings the rolling one-year total performance of the Fund in ZAR to +3.8% (below the benchmark's return of +11.6%) and annualised over the last three years to +8.1% p.a. (note that all returns are net of fees). The ZAR weakened by -27.5% and -23.2% over the quarter and year respectively, as the COVID-19 pandemic impacted Emerging Markets to a greater extent than Developed Markets.

Global Equities did not perform well over the year, with the MSCI World Index down -9.9% in US\$ and -20.9% in US\$ over the last quarter. Global markets were in turmoil due to the COVID-19 pandemic that spread around the world, bringing global economies to a halt. Despite the COVID-19 pandemic, large global technology companies have performed well over the past 12 months with Apple and Microsoft increasing by 33.9% and 33.7% respectively in US\$. The companies that have underperformed over the past 12 months include oil companies, banks and airlines. These companies have been more heavily impacted by the decline in the economic outlook due to the COVID-19 pandemic. The fund underperformed the benchmark over the past year due to its underweight position in large global technology companies as well as its overweight position in Horizons Life Sciences and certain banks.
