The primary objective of the portfolio will be to achieve capital growth with a moderate level of income for investors through investments predominantly in the equity market and to a lesser extent in the fixed interest market and money market.

The Element Earth Equity Sanlam Collective Investments Fund is an actively managed, South African equity general fund that will also be allowed to invest in listed and unlisted financial instruments (derivatives) as allowed by the Act from time to time.

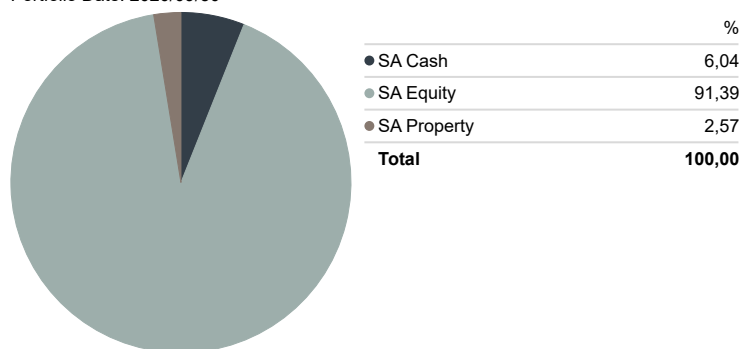

### Risk Profile

#### Aggressive

You can afford to take on a higher level of risk (i.e., have a greater exposure to equities) because of your investment time horizon and/or your appetite for risk. You know that in taking the risk, you need to be patient if you want to achieve the results. So you are willing to invest for the long-term and are prepared to tolerate some volatility in the short term, in anticipation of the higher returns you expect to receive in five years or beyond.

### Glossary Terms

#### Annualised Returns

Annualised return is the weighted average compound growth rate over the period measured.

#### Asset Allocation

Asset allocation is the percentage holding in different asset classes (i.e. equities, bonds, property, etc.). It is used to determine the level of diversification in a portfolio.

#### Cumulative Returns

Cumulative return is the total growth experienced over the period measured.

#### Distributions

The income that is generated from an investment and given to investors through monthly, quarterly, bi-annual or annual distribution pay-outs.

#### Diversification

This is a strategy designed to reduce risk within a portfolio by combining a variety of investments (or asset classes) such as equities, bonds, cash or property, which are unlikely to all move in the same direction at the same time. This is designed to reduce the risk (and protect against capital losses) within a portfolio. Diversification allows for more consistent performance under a wide range of economic conditions as it smoothes out the impact of negative market events. The positive performance of some investments or asset classes should neutralize the negative performance of others.

#### Financial Instruments

Derivatives also known as financial instruments (such as a future, option, or warrants) whose value derives from and is dependent on the change in value of an underlying asset (such as a commodity, currency, or security) to protect against risk (capital losses).

#### Fund Objective

The fund objective is the portfolio's core goal.

#### Fund Strategy

The fund strategy is the way that the fund is managed to achieve the fund objective.

#### Information Ratio

The Information Ratio measures the market risk-adjusted performance of an investment or portfolio. The greater a portfolio's Information Ratio, the better its risk-adjusted performance has been compared to the market in general.

#### Collective Investment Schemes

Collective Investment Schemes (CIS) (also called unit trusts) are portfolios of assets such as equities, bonds, cash and listed property, in which investors can buy units. They allow private investors to pool their money together into a single fund, thus spreading their risk across a range of investments, getting the benefit of professional fund management, and reducing their costs.

#### Market Capitalization

Market capitalization is the total value of the issued shares of a publicly traded company; it is calculated by multiplying the share price by the number of shares in issue.

#### Maximum Drawdown

The maximum drawdown measures the highest peak to trough loss experienced by the fund.

#### Participatory Interests

When you buy a unit trust, your money is pooled with that of many other investors. The total value of the pool of invested money in a unit trust fund is split into equal portions called participatory interests or units. When you invest your money in a unit trust, you buy a portion of the participatory interests in the total unit trust portfolio. Participatory interests are therefore the number of units that you have in a particular unit trust portfolio.

#### Sharpe Ratio

The Sharpe Ratio measures total risk-adjusted performance of an investment or portfolio. It measures the amount of risk associated with the returns generated by the portfolio and indicates whether a portfolio's returns are due to excessive risk or not. The greater a portfolio's Sharpe ratio, the better its risk-adjusted performance has been (i.e. a higher return with a contained risk profile, where the portfolio manager is not taking excessive risk to achieve those returns).

#### Standard Deviation

Standard deviation (also called monthly volatility) is a measure of how much returns on an investment change from month to month. It is typically used by investors to gauge the volatility expected of an investment.

### Portfolio Manager Comment

#### As at 30 September 2020

#### Quarterly Commentary

The Element Earth Equity SCI Fund ("Fund") realised a total return of -2.9% for the quarter to the end of September 2020, behind its benchmark's (FTSE/JSE All Share Index: "ALSI") return of +0.7% over the quarter.

The September 2020 quarterly performance brings the rolling one-year total return of the Fund to -17.0%, below the peer group (ASISA SA Equity General funds) average of -3.0% over the period. The peer group benefited from its exposure to offshore equities, whereas the Fund invests only in local equities. The annualised total return over the last rolling three years was -5.0% p.a. (note that all returns are net of/after fees).

The Fund's underperformance over the past 12 months primarily driven by its underweight position in Naspers and overweight position in Remgro and Adcock Ingram. Naspers, like global technology companies, has outperformed during the COVID-19 crisis. Technology companies have been able to operate during the COVID-19 shutdowns (e.g. social media, gaming and online shopping) and have outperformed other sectors of the economy that have been impacted by social distancing regulations. Remgro has underperformed over the past year due to its large exposure to the South African economy and banking sector. Over the past 12 months it has unbundled its stake in RMH Holdings and this is expected to reduce the discount it trades to its NAV (net asset value). Adcock Ingram has underperformed together with other small and mid-cap counters.
