The Manager shall be permitted to invest on behalf of the portfolio in offshore investments as legislation permits. The portfolio will be managed in accordance with regulations governing pension funds.

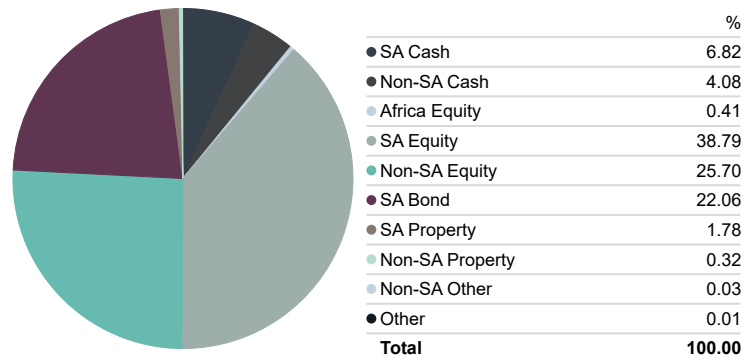
Please note that the amalgamation of the Element Flexible SCI Fund into the Element Balanced SCI Fund took place on the 6 November 2020.

Risk Profile

Moderate Aggressive

Your primary aim is to achieve the required capital growth necessary to realise your long term goals and objectives. You are prepared to tolerate fluctuations in your returns because you know that the longer-term picture is worth the short term pain, even if that means you lose money sometimes. While diversified across all the major asset classes, your portfolio will be tilted more towards equities because you know they offer the best long-term returns of all the asset classes and thus your wealth will grow over time.

Glossary Terms

Annualised Returns

Annualised return is the weighted average compound growth rate over the period measured.

Asset Allocation

Asset allocation is the percentage holding in different asset classes (i.e. equities, bonds, property, etc.). It is used to determine the level of diversification in a portfolio.

Cumulative Returns

Cumulative return is the total growth experienced over the period measured.

Distributions

The income that is generated from an investment and given to investors through monthly, quarterly, bi-annual or annual distribution pay-outs.

Diversification

This is a strategy designed to reduce risk within a portfolio by combining a variety of investments (or asset classes) such as equities, bonds, cash or property, which are unlikely to all move in the same direction at the same time. This is designed to reduce the risk (and protect against capital losses) within a portfolio. Diversification allows for more consistent performance under a wide range of economic conditions as it smoothes out the impact of negative market events. The positive performance of some investments or asset classes should neutralize the negative performance of others.

Financial Instruments

Derivatives also known as financial instruments (such as a future, option, or warrants) whose value derives from and is dependent on the change in value of an underlying asset (such as a commodity, currency, or security) to protect against risk (capital losses).

Fund Objective

The fund objective is the portfolio's core goal.

Fund Strategy

The fund strategy is the way that the fund is managed to achieve the fund objective.

Information Ratio

The Information Ratio measures the market risk-adjusted performance of an investment or portfolio. The greater a portfolio's Information Ratio, the better its risk-adjusted performance has been compared to the market in general.

Collective Investment Schemes

Collective Investment Schemes (CIS) (also called unit trusts) are portfolios of assets such as equities, bonds, cash and listed property, in which investors can buy units. They allow private investors to pool their money together into a single fund, thus spreading their risk across a range of investments, getting the benefit of professional fund management, and reducing their costs.

Market Capitalization

Market capitalization is the total value of the issued shares of a publicly traded company; it is calculated by multiplying the share price by the number of shares in issue.

Maximum Drawdown

The maximum drawdown measures the highest peak to trough loss experienced by the fund.

Participatory Interests

When you buy a unit trust, your money is pooled with that of many other investors. The total value of the pool of invested money in a unit trust fund is split into equal portions called participatory interests or units. When you invest your money in a unit trust, you buy a portion of the participatory interests in the total unit trust portfolio. Participatory interests are therefore the number of units that you have in a particular unit trust portfolio.

Sharpe Ratio

The Sharpe Ratio measures total risk-adjusted performance of an investment or portfolio. It measures the amount of risk associated with the returns generated by the portfolio and indicates whether a portfolio's returns are due to excessive risk or not. The greater a portfolio's Sharpe ratio, the better its risk-adjusted performance has been (i.e. a higher return with a contained risk profile, where the portfolio manager is not taking excessive risk to achieve those returns).

Standard Deviation

Standard deviation (also called monthly volatility) is a measure of how much returns on an investment change from month to month. It is typically used by investors to gauge the volatility expected of an investment.

Quarterly Commentary

The Element Balanced SCI Fund ("Fund") realised a total return of +2.3% for the quarter to the end June 2021, outperforming its benchmark (ASISA Multi-Asset High Equity funds) return of +1.8% over this period. The June 2021 quarterly performance brings the rolling one-year total performance of the Fund to +14.4% (below its benchmark's performance of +17.2%) and annualized total return over the last rolling three years to +4.9% p.a. (note that all returns are net of/after fees). It should be noted that the Fund is outperforming its benchmark over a rolling five-year period.

Despite the impact of the Covid-19 pandemic on global economies, global stock markets continue to rise to record levels. SA Equities (ALSI) were the top performing asset class over the past 12 months with a return of +25.1%, outperforming Global Equities (MSCI World in ZAR), SA Bonds (ALBI) and Cash (STEFI). Most asset classes performed well over the past 12 months with Global Equities and SA Bonds returning +14.9% and +13.7% respectively. Global Equities were negatively impacted by the strong ZAR, which strengthened by +17.7% over the past year. The worst performing asset class over the past 12 months was Cash, which returned +4.0%. Cash's performance was impacted by low short-term interest rates with The South African Reserve Bank reducing the Repo Rate to a low of 3.5% in July 2020.

The fund underperformed its benchmark over the past 12 months. The fund would have benefited from a higher exposure to SA Equities, which was the top performing asset class over the period. However, the SA Equity component of the fund was negatively impacted by its exposure Gold shares and its Global Equities were impacted negatively by the underweight position in Global Technology companies.
