### Fund Objective

The primary objective of the portfolio will be to achieve capital growth with a reasonable level of income that is halaal (permissible) for investors through investment in predominantly the domestic equity market.

### Fund Strategy

The portfolio will invest in equity securities in the JSE that comply with Shari'ah guidelines that govern Islamic Investment Funds and that prohibit investment in companies whose primary business is not consistent with Shari'ah principles. The Manager shall be permitted to invest on behalf of the portfolio in offshore investments as legislation permits.

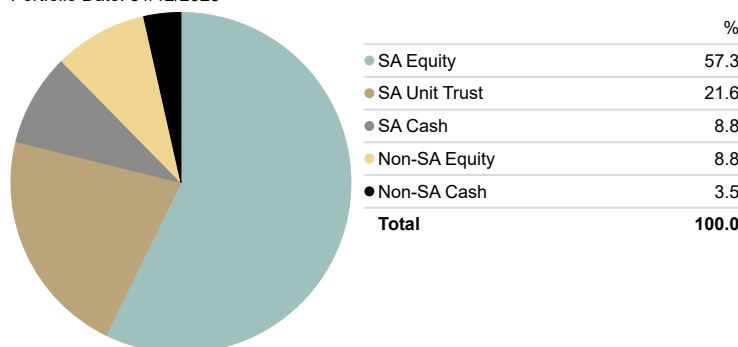

### Risk Profile

You can afford to take on a higher level of risk (i.e., have a greater exposure to equities) because of your investment time horizon and/or your appetite for risk. You know that in taking the risk, you need to be patient if you want to achieve the results. So you are willing to invest for the long-term and are prepared to tolerate some volatility in the short term, in anticipation of the higher returns you expect to receive in five years or beyond.

### Glossary Terms

#### Annualised Returns

Annualised return is the weighted average compound growth rate over the period measured.

#### Asset Allocation

Asset allocation is the percentage holding in different asset classes (i.e. equities, bonds, property, etc.). It is used to determine the level of diversification in a portfolio.

#### Cumulative Returns

Cumulative return is the total growth experienced over the period measured.

#### Distributions

The income that is generated from an investment and given to investors through monthly, quarterly, bi-annual or annual distribution pay-outs.

#### Diversification

This is a strategy designed to reduce risk within a portfolio by combining a variety of investments (or asset classes) such as equities, bonds, cash or property, which are unlikely to all move in the same direction at the same time. This is designed to reduce the risk (and protect against capital losses) within a portfolio. Diversification allows for more consistent performance under a wide range of economic conditions as it smoothes out the impact of negative market events. The positive performance of some investments or asset classes should neutralize the negative performance of others.

#### Financial Instruments

Derivatives also known as financial instruments (such as a future, option, or warrants) whose value derives from and is dependent on the change in value of an underlying asset (such as a commodity, currency, or security) to protect against risk (capital losses).

#### Fund Objective

The fund objective is the portfolio's core goal.

#### Fund Strategy

The fund strategy is the way that the fund is managed to achieve the fund objective.

#### Information Ratio

The Information Ratio measures the market risk-adjusted performance of an investment or portfolio. The greater a portfolio's Information Ratio, the better its risk-adjusted performance has been compared to the market in general.

#### Collective Investment Schemes

Collective Investment Schemes (CIS) (also called unit trusts) are portfolios of assets such as equities, bonds, cash and listed property, in which investors can buy units. They allow private investors to pool their money together into a single fund, thus spreading their risk across a range of investments, getting the benefit of professional fund management, and reducing their costs.

#### Market Capitalization

Market capitalization is the total value of the issued shares of a publicly traded company; it is calculated by multiplying the share price by the number of shares in issue.

#### Maximum Drawdown

The maximum drawdown measures the highest peak to trough loss experienced by the fund.

#### Participatory Interests

When you buy a unit trust, your money is pooled with that of many other investors. The total value of the pool of invested money in a unit trust fund is split into equal portions called participatory interests or units. When you invest your money in a unit trust, you buy a portion of the participatory interests in the total unit trust portfolio. Participatory interests are therefore the number of units that you have in a particular unit trust portfolio.

#### Sharpe Ratio

The Sharpe Ratio measures total risk-adjusted performance of an investment or portfolio. It measures the amount of risk associated with the returns generated by the portfolio and indicates whether a portfolio's returns are due to excessive risk or not. The greater a portfolio's Sharpe ratio, the better its risk-adjusted performance has been (i.e. a higher return with a contained risk profile, where the portfolio manager is not taking excessive risk to achieve those returns).

#### Standard Deviation

Standard deviation (also called monthly volatility) is a measure of how much returns on an investment change from month to month. It is typically used by investors to gauge the volatility expected of an investment.

### Portfolio Manager Comment

#### As at 31 December 2023

#### Quarterly Commentary

The Element Islamic Equity SCI Fund ("Fund") realised a total return of **+5.5% (after fees)** for the quarter to end December 2023. This performance brings the rolling one-year total performance of the Fund to **+8.8% (after fees)**, **ahead of its Islamic Equity Peer average benchmark's return of +8.4%** for the same period.

Similarly, the Fund outperformed its peer benchmark over the last three years to 31 December 2023, returning **+11.9% p.a. after fees** (vs benchmark 11.5% p.a.), **also over the five-year period with +10.5% p.a. after fees** (vs benchmark 9.3% p.a.) **and again over the 10 years to end December 2023 with +6.6% p.a.** (vs benchmark 6.3% p.a.).

Outperformance by the Fund of its benchmark over the 1, 3, 5 & 10 year periods, is something that Element is proud to have achieved for its investors.

The Fund realised profits on Anglogold and Anglos by reducing their % weights in the Fund, but remaining overweight relative to its peer benchmark.

The Fund invests in the **Element Islamic Global Equity SCI Fund** for part of its offshore equity exposure. Investors should please refer to the **Element Islamic Global Equity SCI Fund's** MDD quarterly commentary, with respect to its benchmark being un-investable and therefore, inappropriate as a comparative measure of its performance to date.

Element will update investors, in all three of its Element/SCI Islamic Funds, as well as provide more information and data on performance comparisons that are relevant, once an appropriate and investable new benchmark has been determined for the **Element Islamic Global Equity SCI Fund**, in consultation with Element's Shari'ah Supervisory Board.
